

PARTICIPANT TERMS AND CONDITIONS

1. MFA REGISTRATION

1. By registering with Football Australia (FA) using the FA Registration System (Play Football) (or by registering via the Association's registration system) you (Participant) (or, if the Participant is under 18 years of age, the Participant's parent, or legal guardian (Guardian) and the Participant):
2. agrees that these terms and conditions constitute a legally binding contract between the Participant and Macarthur Football Association Inc (ABN 82 138 352 399) (MFA).
3. warrants that the information provided is current and correct.
4. warrants that the Participant holds only one Play Football account.
5. agrees to comply with:
 - a) the Football Australia Statutes, including the National Registration, Status and Transfer Regulations, National Code of Conduct, National Disciplinary Regulations, National Anti-Doping Policy, and Grievance Procedure;
 - b) the Football NSW Rules and Regulations which apply to Participants;
 - c) the MFA rules, regulations and policies which apply to Participants;
 - d) their registered Club's rules, regulations and policies; and
 - e) the terms and conditions the Participant entered into with FA, FNSW, the MFA and the Participant's Club at the time of registration through Play Football, as published, or provided to, or signed by, the Participant from time to time, including any new or amended rules, regulations, policies and other documents as adopted by the relevant body from time to time (together with the Football Conditions); and
6. agrees that the MFA may enforce any breach by the Participant of the Football Conditions from time to time (including by imposing sanctions, penalties, or other disciplinary actions as it sees fit).

2. FA and FNSW Terms

The terms and conditions set out by Football Australia and Football New South Wales (Football NSW Registration section only), and agreed to by the Participant, by registering through Play Football are deemed to be incorporated in these terms with the MFA with such amendments made such that any reference to FNSW, Football NSW, FA, Football Australia (or similar references to those bodies) are replaced with the MFA for the benefit of the MFA and which is also enforceable by the MFA.

3. Additional Tahmoor Soccer Club Terms

Tahmoor Soccer Club maintains a zero-tolerance policy towards aggressive or abusive behaviour from players or parents directed at any other player, parent and/or referee.

If you choose the wrong size for your playing strip during the registration process, the club will charge you \$30.00 to order a replacement.

4. Refund Policy

If a player requests to de-register and requests a refund, the refund will be processed through Football Australia and refunded to the card payment was originally made. This will take approx. 10 working days.

Tahmoor will refund their portion of the fees as detailed below. The balance of refund is subject to the discretion of Macarthur Football Association, Football NSW, and Football Australia.

Tahmoor will advise Football Australia to refund the club's portion of the fees as follows:

- a) Prior to a player taking the field in any trial matches and/or Round 1 – Tahmoor will retain the sum of \$30.00 being payment of the playing strip.
- b) On or after Round 1 up to including Round 5 – Tahmoor will retain the sum of \$30.00 being payment of the playing strip plus 50% of the club's portion.
- c) On or after Round 6 – Tahmoor will not offer a refund of any portion of the club's fees.
